## **AGM RESOLUTION**

### **1.**

- 1) Existing BWAB General Members will be able to become Lifetime Members by depositing Tk.5,000/- till February/2023.
- 2) New General Membership will be allowed at TK.5,000/- where renewal fee is payable each year.
- 3) New Fee for Lifetime Membership is Tk.10,000/-. Renewal not required.

2. Decided that at the initiative of BWAB existing Lifetime Members new Sub-Committee in the all Divisional and District level will be formed. Interested Lifetime Members are requested to contact with the President, BWAB at the earliest.

3. Some new Members will be inducted in the BWAB Executive Committee. Lifetime BWAB Members who can give time to work are requested to contact with the President, BWAB at the earliest.

4. All the existing BWAB Members shall take effective initiative to increase Members of the BWAB within their friend/familiar circle. This effort will be counted as the outstanding contribution to BWAB. Each contributor in this respect will keep a record under intimation to the President BWAB.

6. 1) In the meantime, **Land has been got registered for BWAB OFFICE TOWER.** Total Plot **booking for 186 Katha** has been given by the interested persons. Development of BWAB-Bankers' Housing Land has been continuing by sand filling and for leveling. Moreover, location of the land is adjacent to Sector-28 of Government approved RAJUK-PURBACHAL area which is very attractive area and valuable, price will be multiple within a very short time. In nearby area land price is more than Taka 15 Lakh per Katha.

2) It has been decided that Plot Owners of BWAB-Bankers' Housing will get Dividend out of net income (After meeting up expenses) from the BWAB TOWER BUILDING (Commercial Space).

This improvement and information should be given to the relatives, known persons so that they get interest to purchase plot of BWAB-Bankers' Housing. This effort will be counted as the outstanding contribution to BWAB. Each contributor in this respect will keep a record under intimation to the President, BWAB.
